Dankort subscription

The annual Dankort subscription is governed by Nets in accordance with Section 23, paragraph 5 of the Danish Act on Payments.

Your company pays an annual subscription to receive payments on Dankort for physical sales.

You will have one subscription per physical sales site with the same CBR.no/owner

Collection of subscription

Subscription payments are collected every quarter in arrears.

At the end of each quarter, Nets calculates the subscription for each quarter, Nets calculates the subscription for each business. The calculation is based on the number of transactions the company has had in the last four quarters.

Subscriptions are automatically deducted. The deduction will reflect on the account statement, Nets does not send out invoices.

New business

Nets calculates the amount of the subscription based on the number of transactions for the last four quarters. New businesses will be charged for the transactions they have had in the period they have existed.

Therefore, they may have a lower quarterly charge for the first two quarters than after Q3-Q4.

Termination

If a business closes, you will be charged for the current quarter immediately after closing. The amount of the subscription is calculated based on the number of transactions for the last last three closed quarters as well as the current quarter.
